WHAT IS THIS PRODUCT? The Fund is a sub-fund of Plurima Funds, an open-ended umbrella unit trust established as an Undertaking for Collective Type Investment in Transferable Securities ("UCITS"), authorised by the Central Bank of Ireland. Objectives The objective of the Fund is to achieve an increase in the value of units over a period of several years. The Fund is a fund-of-funds and therefore invests more than 65% of its net assets in other open-ended funds, either ones that comply with UCITS regulations ('UCITS'), or ones that do not ('non-UCITS'). It may also invest in closed-ended funds, property funds, and financial derivative instruments. The Fund may invest up to 100% of its net assets in UCITS funds and up to 30% of its net assets in non-UCITS funds. Up to 20% of the fund's net assets may be invested in real estate funds (REITs), Exchange Traded Commodities (ETCs) and other closed-ended funds. • The Fund may also invest directly in bonds and debt-related securities, in equity and equity-related securities, and in cash and cash-equivalent instruments. • The Fund may invest in futures, options, and forward currency contracts traded on one or more stock markets or may be negotiated directly with financial institutions. • The Fund is not restricted in its choice of investments by geography, industry, or market capitalisation. It may invest in emerging markets. • This fund is categorised as Article 8 SFDR. The fund promotes environmental or social characteristics, but does not currently commit to investing in sustainable investments. • The Fund is actively managed without reference to any benchmark meaning that the Portfolio Manager has full discretion over the composition of the Fund's portfolio, subject to the stated investment objectives and policies. • This Unit Class does not distribute income. All income is reinvested. This Unit Class is priced in EUR. You may redeem your units in the Fund on each business day. WHAT HAPPENS IF EUROPEAN AND GLOBAL INVESTMENTS LTD. IS UNABLE TO PAY OUT?

The assets of the Fund are held in safekeeping by its depositary, RBC Investor & Treasury Services, Ireland (the "Depositary"). In the event of the insolvency of the Manager, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. WHAT ARE THE COSTS?
